
# **Introducing Integrated Coastal Resources Database (ICRD)**

WARPO received a mandate through the 'Coastal Zone Policy 2005' to set up ICRD, which is linked to NWRD as a sub-set. ICRD is more than a simple database (better be termed as 'knowledgebase'). Data of different sectors of coastal zone of Bangladesh (19 coastal districts) are kept in ICRD. ICRD provides means to prepare an updated and useful status of vulnerabilities and opportunities in the coast, usable for decision makers and a basis for steering the policy processes.

#### ICRD Data Sets

Presently over 450 data layers have been collected and generated for ICRD. The data can be presented based on 6 indicators as follows:

- Administration and Institutions (ADM).
- Economics and Finance (ECO).
- Funds and Interventions (FUN): Water, Health, Food Assisted Program etc.
- Human beings and Social Conditions (HUM).
- Assets, Infrastructure and Services (INF).
- Natural Resources and Environment (NRE).



# International Conference on Water and Flood Management, ICWFM-2007

A three day long International Conference on Water & Flood Management was held at China- Bangladeh friendship conference centre, Dhaka from 12-14 March organized by Institute of Water and Flood management (IWFM), BUET. Water Resources Planning Organization (WARPO) was one of the key collaborative partners with the organizer IWFM, BUET. A total of 125 papers on 7 themes were presented in 20 technical sessions. Total number of participants were 144, including 66 foreign participants from 15 countries. Professor Jahir Uddin Chowdhury of IWFM, BUET was the Chairman of the organizing Committee. Professor A.M.M Safiullah, Vice-Chancellor of BUET was the Chief Guest of the inaugural ceremency. Mr. Kazi Golam Mustofa, DG, WARPO Chaired the two technical session of the conference. WARPO played a key role for successful completion of the Conference.

# Organizational Development Plan (ODP) of WARPO

Organizational Development Plan (ODP) of WARPO is the road map of achieving the WARPO's role, mandate and activities as envisaged in Water Resources Act. 1992, Bangladesh Water and Flood Management Strategy (BWFMS-1995), NWPo, CZPo and PRS-2005. It's a framework Action Plan to initiate a process of improving organizational capacity building and effectiveness. An indepth analysis of above-mentioned policy-documents and stakeholders consultation was made in its formulation process.

Action plan developed in ODP, is expected, to be implemented, in three phases over six years (2006-2011) .eg., inception, development and implementation. The draft ODP was approved by 7th Parichalana Board meeting held on 17th October 2006. A decision was taken in the meeting that WARPO will do the clearing house function experimentally with BWDB projects. Present ODP proposed revised set-up showing total manpower of 205 for discharging the extended responsibilities as emerged from NWPo, NWMP, CZPo etc.

#### Role of WARPO

The main Role of WARPO are as follows:

- (i) Apex planning body of Water Sector
- (ii) Clearing House of Water Sector Projects
- (iii) Monitoring and Evaluation of water sector intervention.
- (iv) Executive Secretariat to ECNWRC/NWRC
- (v) Management of National Water Resources Database and Integrated Coastal Resources Database
- (vi) Co-ordinate and monitor activities in the Coastal zone through PCU
- (vi) Periodic updating of NWMP

## **New Director General Takes over**



Mr. Kazi Golam Mustofa took over as the new Director General of Water Resources Planning Organization (WARPO) on deputation on 01 March 2007. Mr. Mustofa replaces Mr. H. S. Mozaddad Faruque as Director General of WARPO.

Mr. Mustofa graduated from Bangladesh University of Engineering and Technology (BUET), Dhaka in 1974 in Civil Engineering. He completed post graduate diploma on Water Resources from AIT, Thailand in 1980 and post graduate diploma on Computer Science in 1995. Mr. Mustofa was serving as Additional Director General (Planning) of Bangladesh Water Development Board (BWDB) immediately before taking over as Director General of WARPO.

During his long career he obtained several training in home and abroad including China, Thailand, Egypt, Philippines, Nepal etc.

## **New Director - WARPO**



Mr. Md. Arzel Hossain Khan, Superintending Engineer, Bangladesh Water Development Board joined WARPO as Director (Planning)on 27th March 2007 on deputation. Mr. Khan graduated in Civil Engineer from Rajshahi University in 1977 and joined Bangladesh Water Development Board (BWDB) in the same year. He worked in Design and in different development projects of BWDB in various positions.

Mr. Khan worked in Master Plan Organization (MPO) since its inception in 1983 and continued upto 1989. He actively took part in the preparation of National Water Plan (NWP-1). He also served Water Resources Planning Organization (WARPO) from 1999 to 2006 and contributed in the preparation of NWMP and Options for the Ganges Dependant Area (OGDA) study.

He attended different training courses in home and abroad including Thailand, The Netherlands, USA and the Philippines.

Mr. Md. Shajahan. took over the charge of Director (Technical), Water Resources Planning Organization(WARPO) on 22 October, 2006. He was serving as Principal Scientific Officer, Social-Economics section of WARPO since 1997 immediately before his joining in present post. He obtained his B.A. (Hons) and M.A (Economics) from Dhaka University (1975 and 1976).



He has worked for Flood Action Plan (FAP), NWMP, Integrated Coastal Zone Management Plan (ICZMP) and the GoB PRS.

During his long career he obtained several training in home and abroad including France, Thailand, USA, UK and the Philippines.



## **EDITORIAL**

WARPO and its predecessor Master Plan Organization (MPO) began with the preparation of a Master Plan for bringing about harmonization and integration of overall water sector activities with due focus on social and environmental perspective in 1983. National Water Plan (NWP-I & II) of 1986 and 1991, Water Resources Act-1992, FAP Study (1989-1995), Bangladesh Water and Flood Management Strategy (BWFMS, 1995), National Water Policy (NWPo, 1999) and NWMP, 2001 Coastal Zone Policy (CZPo, 2005) and the National Water Resources Database (NWRD) all are milestone activities towards achieving the strategic role in water sector.

WARPO has prepared Organizational Development Plan (ODP) for its institutional reform and strengthening of its capacity in implementation of its strategic role. The most crucial issue is to develop as an apex planning and central coordinating body through acting as a "clearing house" for all the water sector projects. WARPO has attempted to develop inter-agencies linkages, strong information base, necessary tools and techniques to perform those role entrusted through a 5-year plan soon after the completion of NWMP. However present ODP is a broad based 6-year action plan, to be implemented in three phases. Parichalana Board of WARPO approved the ODP on 17th October 2006 with emphasis on to play the "clearing house role" initially with the BWDB projects. ODP, the milestone action list for capacity building of WARPO, should get due attention to all concerned to materialize the longterm aspiration in the water sector.

## **Twinning Mission (TM)-XVI**

Twinning Mission-XVI visited WARPO on 20th February 2007. They met with Director General, and discussed about ODP process and WARPO strategy. Director (Technical) and Task Force Coordinator assisted DG in the discussion. After the meeting with DG, the TM-XVI hold two discussion sessions with WARPO Task Force. Progress on Development Phase of ODP, Follow up Activities of TM-XV, Monitoring NWMP Implementation, updating of NWMP and Module of management training programme of WARPO were the main issues in the disscussion.
