Planning needs, institutional reforms, refining the long-term national water management strategy and revising the portfolio of programs of the NWMP for the medium and the longer term will be considered in the NWRP.

The specific objectives of the project are:

To promote decentralize Water Management in Bangladesh through Strengthening of framework to enable stakeholder participation in the water sector planning process and regular public review of progress
